The Abstinence program funds locally based organizations serving youth ages 12 to 18. These programs are each different in design and implementation. Yet each is an example of how abstinence education is relationship training designed to: Help youth develop the life skills and support network necessary to resist the pressures that lead to high-risk premarital sex;

Educate parents about ways to promote positive behavior in their children; and Encourage a societal environment in which abstinence is viewed as the standard through which youth have the greatest potential to strive now and in the future.

Viral Hepatitis Program

The Viral Hepatitis program seeks to promote the prevention of viral hepatitis by increasing disease awareness and prevention options; disseminating educational materials about services; communicating strategies for detection and treatment; designing screening protocols and providing information and referral services. Activities currently underway within the program are perinatal hepatitis B case management, Hepatitis immunization outreach to at-risk populations, Hepatitis C prevention awareness and promotion. The program is also working on collaborative projects with Denver Health and the Hep C Connection. These projects are designed to integrate hepatitis prevention messages into existing services in the STD/HIV clinics and correctional facilities; and to provide information and services to those who are infected. Many new projects will begin in the months to come and the program will expand its capacity to analyze hepatitis morbidity data.

Women's Health-Family Planning Program

In 66 sites throughout Colorado, over 47,000 women and men receive family planning services annually. Eighty-eight percent (88%) of the patients served have incomes at or below 150% of poverty. Patient fees are determined by the patient's income and the ability to pay. Over 27,000 unintended pregnancies are prevented each year in Colorado as a direct result of state and federally funded family planning services. Colorado family planning clinics provide a range of preventive health services, including: Physical exams for women and men Cervical, breast, and testicular cancer screening. Birth Control information and supplies. Screening for sexually transmitted infections and HIV Health education and counseling, including information regarding abstinence Pregnancy testing

Basic infertility services Referrals to other health and social services. Family planning clinics often are an entry point into the health care system for women and families who otherwise lack access to health care services. Family Planning services help: Prevent unintended pregnancies, reduce the number of abortions, lower sexually transmitted infection rates, including HIV, improve women's health. The Family Planning Program does not subsidize abortion services.
