

## WHAT ELSE SHOULD I KNOW?

An alcohol program the court orders you to complete may differ from your Motor Vehicle reinstatement requirements.

Education and therapy classes must begin after the date of your most recent alcohol violation.

Colorado Revised Statute (CRS 42-2-132) requires completion of a Level I or Level II alcohol education and therapy program, and provides for the Affidavit of Enrollment.

If you used an Affidavit of Enrollment, DR 2643, in-lieu of a completed Level II to reinstate your privileges and the Department receives notice from the DBH provider that you are non-compliant with the Level II program **OR** we have not received completion of your Level II course within 20 days after the *estimated completion date* listed on the DR 2643, your license/privilege will be Cancelled & Denied for failing to complete the Level II. A letter will be mailed to you at your last known address on record with Motor Vehicle. When a letter is sent, you will need to provide proof that there was no lapse in your enrollment (renewed enrollment) or completion of a Level II program. You cannot use an Affidavit of Enrollment once the Cancel & Deny restraint becomes active.

## ALCOHOL CLASSES AND WHAT YOU SHOULD KNOW ABOUT THEM

## LEVEL I

### What is a Level I?

Level I consists of 12 hours alcohol education over a minimum of two sessions, unless an alcohol evaluator says more is required.

### When is a Level I required?

Completion of a Level I alcohol education program is required when a minor driver has had their license/privilege revoked for one year for their first DUI, DWAI or .02 or more BAC conviction, for a violation that was received while under the age of 21. A minor driver may be required to complete Level II education or Level II education and therapy depending on the alcohol evaluator's recommendations.

Level I alcohol education and Level II alcohol education/therapy programs, as required by statute, are defined by the [Division of Behavioral Health \(DBH\)](#) of the Colorado Department of Human Services.

## LEVEL II

### What is a Level II?

Level II consists of an alcohol education and therapy program, as defined by DBH, and are identified in their chart as Tracks A, B, C, and D, shown above.

A Level II is required when a driver:

- Is convicted of 2 alcohol violations that occurred within 5 years, **OR**
- Is convicted of 3 or more alcohol violations in a lifetime, **OR**
- Is revoked for having a BAC of .17 or more, **OR**
- Is revoked for multiple BAC tests of .08 or more (Per Se).

## ENROLLMENT

### What is an Enrollment?

An 'Affidavit of Enrollment', (DR 2643) completed by a DBH certified treatment agency, allows a driver who is required to complete a Level II course for reinstatement, to attend and complete their education and therapy program after and *as a condition* of reinstatement.

### Who is eligible to use an 'Affidavit of Enrollment'?

Any driver, required to have a **Level II** program for reinstatement, that is a **Colorado resident**, is currently enrolled in an approved Level II program, and is eligible for reinstatement but has not yet completed their Level II program, can use the Enrollment.
